

Maryland LAN Gamers Computer Rental Agreement

This form is **required** for anyone renting a computer from Maryland Lan Gamers (MLG). This form must be signed by the renter (or the renter and a parent/guardian over the age of 18 years old should the user be under 18 years of age).

Definitions: (1) Maryland LAN Gamers (renter; also known in this agreement as MLG); (2) *Renter* (person renting the machine, must be over 18 years of age); (3) *User* : Person authorized to use the rented computer as contained in this agreement (must be known to the renter); (4) *Authorized users*: Person(s) authorized to use the rented computer; (5) *Equipment*: Any computer or part thereof that is rented from Maryland Lan Gamers.

First, Maryland LAN Gamers (MLG) does not condone or encourage any illegal activity while connected to the LAN. The LAN's sole intended use is for the facilitating of game play and the exchange of game updates that are required for game play. The exchange of any illegal items such as software, music files (MP3s) or any other material that is not game play related is not permitted. This said, it is agreed that any person renting a computer (or any part thereof) shall **NOT** take part in any activity listed above. Any person renting an MLG computer that is found to be involved in any illegal activity will forfeit their use of the computer (or any part thereof) with out any refund of entrance or rental fees.

The renter and user agree NOT to make ANY system changes (hardware, software, BIOS) to the computer. This includes but it not limited to changing hardware or software settings involving the operating system, supplemental software applications, etc. that are installed on the rented computer by MLG.. This excludes renter installed games and games only. Game settings may be changed to suit renter/user preferences. **OVERCLOCKING OF ANY COMPUTER COMPONENT IS NOT PERMITTED AND THE RENTER/USER WILL IMMEDIATELY BE EJECTED WITH NO REFUND.** The renter/signature party is responsible for ANY damage to the equipment while under their use and care. This is regardless of reason. YOU are responsible for the equipments safe return.

The users must be a signature party on this agreement. No other persons, other then the renter and user contained on this agreement, may use the rented MLG equipment. The rental fee includes the entrance fee for one (1) person. The renter may, upon verbal or written approval of an MLG Staff member present at the LAN, install supplemental software on said rental computer. This software can only be GAMES for game play during the LAN. NO other software of any kind, type or purpose is permitted. Rental fees are NON REFUNDABLE. Should a LAN be postponed for some unforeseen circumstance, a credit will be provided for a rental unit at the NEXT SCHEDULED LAN only. All Rental fees must be paid in advance. MLG does it's best to ensure many hours of quality gaming during an event. MLG is not responsible for unforeseen circumstances that may alter the amount of time a LAN is actually held (weather, power, etc.).

NOTE: Anyone caught violating any of the above rules is subject to ejection with no refund of the rental or entrance fees paid. No credits / refunds will be made. The rental fee is \$85 (inc. entrance. fee).
